Their focus will be on issues related to paddy procurement, such as the hiring of storage facilities (godowns), securing bank guarantees from rice millers who have previously failed to return milled rice to the government, determining milling charges for these millers, and addressing concerns regarding the drying of wet or moisture-laden paddy. The committee has been directed to present its report to the state government as soon as possible, according to orders issued by chief secretary A Santhi Kumari on Wednesday, October 9.

More manpower for Anti-Narcotics Bureau: Telangana DGP

TELANGANA GOVT RELEASES RS 79 CR FOR CROP DAMAGES DURING FLOODS



The Telangana government has allocated Rs 79 crore in compensation for farmers affected by recent floods and heavy rainfall. From August 31 to September 6, these weather conditions resulted in significant crop damage across 79,574 acres in 28 districts. Agriculture minister Tummala Nageswara Rao said that Khammam district experienced the most severe impact, with 28,407 acres affected, followed by Mahabubabad at 14,669 acres and Suryapet at 9,828 acres.In the other 22 districts, crop damage varied from as little as 19 acres to a maximum of 3,288 acres, according to officials from the agriculture departmentThe minister confirmed that compensation of Rs 10,000 per acre has been directly deposited into the accounts of the

GHMC introduces sirens, **CCTV** to curb garbage dumping in Hyderabad

In a bid to tackle the issue of garbage dumping in vulnerable spots across the city, the Greater Hyderabad Municipal Corporation (GHMC) is implementing a new siren system aimed at deterring people from littering. The innovative system will activate a loud siren when someone throws garbage in designated "Garbage Vulnerable Points" (GVPs). This initiative is part of GHMC's ongoing efforts to eradicate such dumping sites, which have persisted despite previous clean-up attempts.



While GHMC had earlier made attempts to eliminate GVPs across the city, some areas continued to be plagued by illegal garbage dumping. In response, the municipal body is now installing CCTV cameras in collaboration with local Residential Welfare Associations (RWAs) to monitor these areas and enforce the new siren system.

In a disappointment for IAS officer Amrapali Kata, the ministry of personnel, public grievances and pensions rejected her peititon to be allocated the Telangana cadre on Wednesday, October 9. The IAS officer currently serves as the GHMC commissioner in Telangana.

The IAS officer from the 2010 Andhra Pradesh cadre requested to be considered for the Telangana cadre, but the request has now been denied based on the recommendations of the Khandekar Committee. The committee noted that Kata had challenged the guidelines for IAS officer allocation after the bifurcation of Andhra Pradesh in 2014, a move that



was previously upheld by the High Court. In its detailed report, the

committee highlighted that Kata had listed her "permanent address" as Visakhapatnam in her UPSC application and sought to be treated as an insider of Telangana. However, the Pratvush Sinha Committee, responsible for the initial allocations, had already denied this request

The ministry accepted the Khandekar Committee's recommendation, affirming that the allocation of officers from the undivided Andhra Pradesh cadre followed uniform procedures grounded in material facts. The High Court also reiterated the importance of adhering to these guidelines, warning that any

The Khandekar Committee emphasized that her allocation to Andhra Pradesh was based on factual records and the same criteria used for all officers during the bifurcation. (BRS) MLA KT Rama Rao (KTR), Thursday, October 10, filed a defamation case at the Nampally court against Telangana minister Konda Surekha, over her remarks linking him to Tollywood's Akkineni family and actor Samantha Ruth Prabhu. This follows a legal notice sent to minister Surekha, on October 2, demanding the withdrawal of her alleged derogatory statements, and an unconditional public apology for "tarnishing his reputation", within 24 hours. The minister is also facing a defamation case filed by actor Nagarjuna Akkineni on October 3, regarding the issue, which had caused a huge uproar in the state. "Don't use the lives of movie stars who stay away from politics



to criticize your opponents. Please respect other people's privacy," Nagarjuna had said condemning the minister's statements, a day earlier. "As a woman in a responsible position, your comments and accusations against our family are completely irrelevant and false. I request you to withdraw your comments immediately," Nagarjuna added.

The court has scheduled a hearing over the case for October 23.Also Read-Nagarjuna files defamation case against Telangana min Konda Surekha Actor Samantha Ruth Prabhu, another party linked to minister Konda Surekha's words, following which the minister publicly apologised to the actor. The events which cooked up a storm in Telangana's polity and social space, unfolded when Konda Surekha made a statement accusing KTR of being responsible for the divorce of actors Samantha Ruth Prabhu and Naga Chaitanya. Konda Surekha's remarks On October 2, while addressing the media, Konda Surekha made controversial statements against KTR, accusing him of being the reason behind Samantha and Naga Chaitanya's divorce. "KTR is 100% responsible for Samantha-Naga Chaitanya's divorce. He demanded that Samantha be sent to him in return for not demolishing the N-Convention. Nagarjuna asked Samantha to go to him but she refused to go. So they asked her to leave, that's how the divorce happened,"

Council previously revealed that in 2016, 75% of road accident fatalities were not wearing seat belts. Thanks to awareness campaigns like #SelfiewithSeatBelt, By 2023, seat belt usage in India rose to 83% for frontseat occupants and 30% for rear-seat occupants, showing significant improvement due to increased awareness and safety campaigns.
